









## Doing Business in Scotland and Italy: The Legal Perspective

<u>The British Chamber of Commerce for Italy</u>, together with the <u>Italian Chamber of Commerce and Industry for the UK</u>, The <u>Faculty of Advocates</u>, The <u>Law Society of Scotland</u>, <u>Scottish Development International</u>, <u>finance community.it</u> and <u>legal community.it</u> have joined forces for this important networking event.

This is an excellent opportunity for firms in Italy and Scotland to get to know each other and understand the respective legal systems and issues facing cross border clients.

### The Scottish and Italian Economies

The total value of international exports from Scotland is over £25 billion (Euro 30 billion) of which around two thirds is from the manufacturing sector and one third (but rising) is from the services sector. The top 5 exporting industries are food & beverages, manufacture of refined petroleum and chemical products, legal, accountancy, management, architecture, engineering, technical testing and analysis activities and financial and insurance activities. Italy is in the top ten of export destinations taking around GBP 0.6 billion (Euro 0.75 billion) annually.

Italy does not publish statistics for exports to Scotland separate from the United Kingdom. Total annual exports to the UK as a whole have averaged around GBP 15 billion (Euro 18 billion). Applying the 3.5% of total UK imports from the EU that Scotland takes to that figure, means that Scotland imports more or less what it exports to Italy.

Both countries have recently seen an exponential increase in the services sector and in particular legal services have become a significant element in both countries' export drives.
