Geographical Indication-New IP Object in Russia



- A new intellectual property object a geographical indication has been introduced in the Russian Federation (Federal Law No. 230-FZ of July 26, 2019).
- The said Federal Law has complemented the provisions of the Civil Code of the Russian Federation.
- A geographical indication is a sign used to identify goods as originating in a certain geographical area, the quality, reputation or other characteristics of which are essentially linked to their geographical origin (Paragraph 1 of Article 1516 of the Civil Code of the Russian Federation).
- The aforementioned provisions of the law are to enter into force as of July 27, 2020.

The same	originating in a specific place, region or country;
The same	whose given quality, reputation or other characteristic is essentially attributable to its geographical origin;
The same	of which at least one of the production steps takes place in the defined geographical area.

Up to present, the Russian legislation has provided protection only to **Appellations of Origin of goods (AO)**.

An AO to which legal protection is granted is a sign that represents or contains a contemporary or historical, official or unofficial, full or abbreviated name of a country, city or rural settlement, locality, or other geographical object and also a derivative of such appellation which became known as a result of its use to designate the special properties of goods which are defined exclusively or mainly by the natural conditions and/or human factors specific for the geographical object concerned (Article 1516 of the Civil Code of the Russian Federation).

Strict requirements are the main reason why so few applications for AOs are being filed in Russia.

One of the requirements is that an application shall be accompanied by **the opinion of a competent governmental body** confirming that the applicant, within the borders of the geographical object concerned, produces goods, the specific properties of which are exclusively or mainly determined by natural and/or human factors specific for the geographical object concerned.

Case Analysis (EMILIA, Case No SIP-185/2018)

- On June 30, 2014, an application for an AO for the designation "EMILIA" was filed in respect of wine in the name of 25 Italian companies.
- At the examination stage, the Certificate of Protection of Protected Geographical Indication (PGI) issued by the Ministry of Agricultural, Food and Forestry Policies of Italy was submitted.
- On August 4, 2016, the Russian PTO refused its registration due to the unconformity of the latter to the requirements for an AO. The reason was that the designation "EMILIA" had not been protected as an AO in Italy.

Case Analysis (EMILIA, Case No SIP-185/2018)

- On November 3, 2016, an opposition against the decision of refusal was filed with the Chamber for Patent Disputes.
- The opposition was dismissed.
- On March 30, 2018, the applicants filed a statement of claims against the decision of the Russian PTO with the Intellectual Property Rights Court (hereafter the Court).
- The Court ruled that the opposition must be re-considered by the Chamber for Patent Disputes. The Court stated that the Chamber for Patent Disputes must establish which category of Gls the designation "EMILIA" fell into.

Case Analysis (EMILIA, Case No SIP-185/2018)

- The Supreme Court upheld the decision of the Intellectual Property Rights Court.
- When re-considering the case the Chamber for Patent Disputes pointed out that Russian AOs were equal to European PDOs (Protected Designations of Origin).
- Considering that, in accordance with all the provided documentary evidence, the applied designation "EMILIA" has fallen into a category of PGIs, it cannot be protected as an AO in Russia.

Case Analysis ("NAPA VALLEY", Case No. SIP-237/2017)

- The Chamber for Patent Disputes decided on the above case that the essence of the object protected by virtue of American certification mark No. 4853438 "NAPA VALLEY" for wines did not coincide with the essence of an AO protected under the Russian law.
- Starting from July 27, 2020, it will be possible to reapply for both designations "EMILIA" and "NAPA VALLEY" to protect them as GIs in Russia.

GIs can be registered in the name of:

- Individuals;
- Legal entities;
- Association of goods producers, raw materials producers, packers, distributors and others;
- Registration of a designation as a GI identifying the goods as originating from a foreign territory is possible provided that the said designation is protected as a GI in its country of origin.

- A registered GI is protected for 10 years from the date of filing and is renewable for every 10 years as long as it is still possible to produce the goods which meet the requirements for GIs established by the Civil Code;
- A renewal request must be accompanied by documents confirming that an applicant manufactures goods having certain characteristics appearing on the State Register of GIs;
- With regard to a GI identifying goods as originating from a territory located out of Russia, a rights holder must submit a document confirming its right to the respective designation in the country of origin at the date of filing a renewal request.

The following actions constitute an illegal use of a GI:

- The use of a registered GI by persons <u>having no right</u> to use it even if they indicate the actual place of origin of goods or the use of a GI in a translated form or together with such expressions as "kind", "type" or "imitation";
- The use of a registered GI by persons <u>having the right</u> to use it in respect of those goods being deficient in the characteristics recorded in the State Register or with regard to those <u>goods</u> <u>manufactured out of the geographical region</u> recorded in the State Register;
- The use of a designation being <u>similar</u> to a registered GI in respect of any goods and being <u>capable of misleading</u> consumers as to the place of origin and properties of goods or the quality, reputation or other characteristics of goods.

The following actions do not constitute an illegal use of a GI:

 The use of a registered GI by third parties in respect of goods entered into the channels of commerce directly by the rights holder or with its consent.

The legal protection of a GI shall be terminated if:

- the rights holder has lost the right to produce goods having certain characteristics recorded in the State Register;
- the rights holder <u>systematically fails to follow</u> the method of production, storage conditions and transportation of goods appearing in the State Register.
